MEMORANDUM

With the objective of settlement of old outstanding dues, TSECL hereby introduces "One Time Waiver of Surcharges for Realization of Old Outstanding Dues from Defaulting Consumers" Scheme as an opportunity for the defaulting consumers to clear their old outstanding dues. Successful implementation of the scheme would provide benefit to the defaulting consumers for one time settlement of their old outstanding. The scheme would be valid from 1st Nov'2018 to 31st Dec'2018. The scheme has two main parts as listed below:

Scheme – A [For Defaulting / TDC / PDC – Kutirjyoti Consumers]

- i) Defaulting / TDC / PDC cases will only be considered under the scheme.
- ii) One time payment system: 75% waiver of surcharge on the condition that entire outstanding including 25% surcharge are paid.
- iii) Scheme inapplicable in cases where surcharge has been accumulated against the bill raised for any malpractice.
- iv) Scheme is valid from 1st Nov'2018 to 31st Dec'2018.
- v) Last date of clearing the dues for the schemes 31st Dec'2018.

Scheme – B [For defaulting / TDC / PDC Consumers of all categories except Kutir Jyoti Consumers].

- i) Temporarily disconnected consumers, who have been disconnected continuously for 6 months or more as on September, 2018 / PDC / Freeze consumers can apply.
- ii) One time payment system: 60% waiver of surcharge on payment of entire outstanding dues including 40% surcharge at one time.
- iii) Scheme inapplicable in cases where surcharge has been accumulated against the bill raised for any malpractice.
- iv) Scheme is valid from 1st Nov'2018 to 31st Dec'2018.

Last date of clearing of dues for both the cases of the scheme is 31st Dec'2018. The cases already settled earlier will not be re-opened in both the cases of the scheme. Corporate office will publish the scheme in the local news paper, electronic media, TSECL as well as Government websites and TV for wide public awareness. However, all AGMs/DGMs are also requested to make wide publicity under their jurisdiction for successful implementation of the scheme.

The billing authority is authorised to administer the surcharge waiver schemes. Division wise consolidated statement of realization of old outstanding dues and waived amount should be submitted (both hardcopy & softcopy) by each Division fortnightly from the date of effect of the scheme till closure in the prescribed format (copy annexed) for information and further necessary action at corporate office level. A sample copy of application-cum-registration form for availing surcharges waiver scheme is also annexed.

The above is for compliance by all concerned officials with immediate effect.
